# **General Instructions**

### TMV 1000 ++ txellence in Education 1921

### Curriculum

- i. Master of physiotherapy is a regular degree program of 2 academic years with compulsory clinical postings and dissertation submission.
- ii. The candidate should have completed Research Methodology and biostatistics, Ethics, Administration and Professional Practice and Teaching technology module in the first sixmonths following admission.
- iii. Submission of synopsis: Every candidate shall submit to the Registrar of the University in the prescribed proforma, a synopsis containing particulars of proposed dissertation work within four months from the date of commencement of the course or on or before the dates notified by the University. The synopsis shall be sent through the proper channel after approval of institutional ethics committee. Such synopsis will be reviewed and the dissertation topic will be registered by the University.
- iv. Dissertation: Every candidate presenting himself / herself for the examination for the first time shall submit, at least four months prior to the university examination, copies of a dissertationnot less than 2500 words consisting of the result of his/her own study carried out under the guidance of a recognized post graduate teacher together with review of recent advances pertinent to that theme. The acceptance of the dissertation by the examiners shall be acondition precedent to the admission of the candidate for the written & clinical (practical)examination. Dissertation should be based on the specialty subject. A candidate who has submitted his/her dissertation once will not be required to submit a fresh dissertation if he / she re-appears for the examination in the same branch on a subsequent occasion, provided that the examiners have accepted the dissertation. The Degree of Master of Physiotherapy (speciality) shall not be conferred upon a candidate unless he / she has passed in the written and clinical examination (including viva voce) andthe dissertation prescribed for the examination in accordance with the provision

It is mandatory for the candidates to complete one value added course from MOOC/ SWAYAM/ EMOOC websites.

# Eligibility for appearing for Exams

• The candidate should have 90% attendance and completed the dissertation work.

# Assessment

• University Exams will be conducted in therotical and practical mode at the end of two years.



### Examination rules for Master of Physiotherapy

- The subject constitutes of Theory and Practical examination. The heads of passing of for a subject will be as under
  - i) Theory ii) Practical or

i) Theory for subjects without having Practical

• The candidate to be eligible to pass in a subject (theory) should secure minimum 40% marks in individual subject and minimum 50% of total marks.

The candidate to be eligible to pass in a subject (Practical) should secure minimum 50% marks in individual subject and minimum 50% of total marks.

If the candidate fails either in Theory or in Practical Examination of a subject will be considered as failing in that subject and he/ she will have to appear for both theory and practical/ clinical examination again.

### • Maximum number of attempts and period for passing :

The applicant shall pass the examination in Six attempts or within Four years from the date of admission whichever is earlier. There after the examinee shall automatically stand debarred from the respective course.

# Internal Assessment :

A college level exam will be conducted at the end of two years before university exam.

### External Assessment (Vidyapeeth Examination)

### Schedule of Examination :

Vidyapeeth examinations are conducted according to the examination time-table notified by the Vidyapeeth by the end of each year. Students are required to appear for the written as well as oral/ practical examination as per the syllabus of their branch.
