Important Notice for Students

- Considering the challenges of the Pandemic situation throughout, we have opened the admission process of the next academic year 2020-21 from June 15, 2020.
- The students of first, second and third year for all programs have to enroll through the online admission process at the earliest.
- The students can avail the admission process **before appearing** for the online examinations. In case of any backlogs of July 2020 exam, the student will be given an opportunity to take admission prior to the result and to appear for the back-log exams in the next academic year i.e. 2020-2021.
- In case of any backlogs in the exams prior to the July 2020 exams, the student will be given an opportunity to take admission prior to the result and to appear for the back-log exams in July 2020 exams the next academic year i.e. 2020-2021.
- All students should pay their pending fees of the earlier academic year 2019-20. The payment of pending fees, if any should be made minimum two weeks prior to the commencement of online exams. **Only the students with the no dues certificate will be eligible to take admission to academic year 2020-21.**

The documents required for Admission Process 2020-2021

- Previous semester mark list and Photograph.
- Caste certificate and validity if applicable.
- Minimum 50% payment of fees.
- **No Dues Certificate**
- Screen shot of payment transaction and all documents to be submitted in the department upon successful completion of admission process. Alternatively send the screen shot to admission@tmv.edu.in, finance@tmv.edu.in with due all the details like – PRN, Course Name.

Note :

- 1) Please carry the Original documents for Verification. All Original documents will be returned to you.
- 2) All foreign students must take English Language Proficiency Test. Clearance of this test is a must for firm admission.
- 3) You need to report to the FRO for registration. You must register within 14 days of your arrival.
- 4) **Registration validity.**
For 2 years Programme - 4 years
For 3 years Programme - 5 years
For 4 years Programme - 6 years

- Fee for Out of Maharashtra Students - 3 times eligibility fee.

MODE OF PAYMENT FOR INDIAN STUDENTS

- Fee should be paid by Demand Draft in favor of **Tilak Maharashtra Vidyapeeth, Pune** along with the application form.
- If payment is to be made at the Vidyapeeth's other premises, namely, Sangli, Belapur, Sion etc. the DD should be payable at the respective place but in the name of **'Tilak Maharashtra Vidyapeeth'**.
- Mention your name and address at the back of the DD.
- Demand Draft is accepted only of a nationalized bank.
