Following points were discussed in the meeting:

- 1. Honourable Vice Chancellor Congratulated all the IQAC members for getting B++ grade in NAAC reaccreditation in the second cycle, visit in the month of September 2018. He said Vidyapeeth's target is to get 'A' grade and we must start preparing from now for the next cycle.
- 2. IQAC Coordinator, Dr.Abhijit Joshi put forth NAAC peer committee report in front of the IQAC committee. He informed the members that NAAC peer team committee as highlighted three major features of Vidyapeeth. They are: Putting into action the vision and mission of Lokmanya Tilak, oldest department of Sanskrit and Indological studies spreading the awareness of the Indian culture and heritage, uniqueness of Journalism-Mass communication and Hotel Management Departments in imparting the training.
- 3. Criterion wise NAAC peer committee report was discussed in the meeting. Committee seems to be satisfied with Criterion I & II with few suggestions like to bridge up the gap to facilitate better career advancement for students especially from physiotherapy, Yoga, and Law departments and the traditional examination system currently in use needs to be replaced with fully automated system. Dr.Suvarna Sathe informed all the members from current academic year many processes such as filling up of Examination form, backlog forms, etc. are done electronically and Examination Dept. is planning for complete automation in the near future.
- 4. Committee was happy with the Extension activities carried out by Vidyapeeth and suggested to correlate these activities with Vision and Mission of Vidyapeeth. They highlighted need to strengthen the innovative ecosystem by encouraging faculty and students by promoting innovation, incubation, transfer of technology and commercialization of various technologies. Committee also mentioned that Vidyapeeth should try to attract industry investment for this purpose and involvement of Alumni can help in effective evolution of Innovative Ecosystem.

- 5. Committee was satisfied with the Infrastructural facilities of the Vidyapeeth but suggested to have an estate department to coordinate better implementation of infrastructural requirements.
- 6. Committee appreciated active student participation in Student Council & Alumni's active contribution but commented that Alumni Association is not formally registered. They also commented on Psychological and academic needs of International Students.
- 7. NAAC Peer team Committee commented that the governance has scope of improvement in tune with the vision and mission of the Vidyapeeth. Broad based involvement of experts and prominent citizens in various regulatory bodies is suggested. It also suggested that mobilization of funds need regular and effective representation with the state government and other government agencies.
- 8. Committee appreciated the Institutional values & Best Practices and suggested to take interest in students amenities like sports, common rooms, counselling room etc. They have also listed a few weaknesses and challenges of Vidyapeeth. Honourable Vice Chancellor said we need to start working on these weaknesses and challenges to excel our performance.
- 9. Dr.Abhijit Joshi thanked all the members of the Committee for their support and cooperation extended.
