Following points were presented and discussed in the meeting:

1. To take a review of the various activities done in the Vidyapeeth during the year.

Resolution No.: IQAC/2019/08

Honourable Vice Chancellor Dr.Deepak Tilak briefed all the members about the various Academic, Research and cultural activities done in the Vidyapeeth during the year.

2. To take review of status of various Research Projects of Vidyapeeth

Resolution No.: IQAC/2019/09

It was informed to the committee that Vidyapeeth has received Government Funding for 3 projects. Out of which, two projects are of Shri Balmukund Lohia Center of Sanskrit & Indological studies and one project to Department of Ayurveda. Department of Ayurveda has submitted another proposal to CCRAS, New Delhi for a Collaborative research project and awaiting approval for the same. It was also informed that 11 proposals for Research Projects from various Departments are received by Lokmanya Tilak Center for Research & Development. Out of which 5 projects are already approved and mobilization amount has already been disbursed. Other proposals are under consideration and will be processed immediately.

3. To take a overview of the various National or International Conferences organized in the Vidyapeeth

Resolution No.: IQAC/2019/10

Conference held by Vidyapeeth on the occasion of Death Centenary of Lokmanya Tilak was a great success. Total 200 registrations were done and 124 papers are

published in Scopus, various UGC approved Journals and Mahratta. Department of Journalism and Mass Communication, Department of Hotel Management, Department of Ayurveda, Institute of Nursing & Research, Department of Computer Science has already conducted their National/International Conferences and publication of Conference proceedings is in progress. Conferences of Department of Management, Department of Social Work and Department of Physiotherapy are scheduled this month.

4. To take note of revised Fee structure for the Academic year 2020-21

Chief Accountant informed that new fee structure is prepared with 10% raise in last year's fees. Members took a note of the same.
