Guest Lecture by Shri Dilip Boraste, Additional Superintendent of Police, Anti Corruption Bureau, Maharashtra State, Pune Unit on 29th August 2019

Topic: Crime Investigation and filing of Charge Sheet in present scenario.

Brief Summary:

Law Department on 29th August 2019 organised a guest lecture of Shri Dilip Boraste, Additional Superintendent of Police, Anti Corruption Bureau, Maharashtra State, Pune Unit and recipient of Presidential Police Medal. The lecture was on the topic "Crime Investigation and filing of Charge Sheet in present scenario."

Principal Dr. P. D. Joshi and all the faculty members were present for the occasion.

Shri Suresh Ghatge, Student of LLB-III welcomed the Guest Speaker and all others present.

Principal Dr. P. D. Joshi gave a brief introduction to the subject and felicitated Shri Boraste.

Shri Jonathan Benn, Student of LLB-III introduced Shri Boraste to the Students.

Shri Dilip Boraste is a student of LLB-II at our College. He joined the Police Force in the year 1986 as a Police Sub Inspector (PSI). During his 33 years and 6 months of service he has been posted at various centres like Mumbai, Nagpur, Ratnagiri, Nasik, Thane and at the Criminal Investigation Department, Maharashtra State. He is holding the present position at the Anti Corruption Bureau, Pune since 2016.

He has received the award for the Best Criminal Investigation at the hands of the Director General of Police, Maharashtra State on three occasions.

Shri Boraste discussed the various stages of Criminal Investigations right from the stage of filing of FIR (First Information Report), Collection/Recording of evidence, preparing of the Charge Sheet/Final Report to finally handing over the case to the Prosecutor/Special Prosecutor appointed. The talk was very interesting as he was substantiating the various aspects involved during the various stages of the criminal investigations with his own personal experiences.

Shri Dilip Boraste is instrumental in solving the famous Multiple Child abduction and murder case of 1997 at Nasik. The serial killer sisters Seema Gavit and Renuke Shinde along with their mother Anjanabai who died as an undertrial in Dec 1997, 14 months after she was arrested at Nasik, kidnapped 13 children of under five years of age and brutally murdered nine of them between 1990 and 1996. The kidnapped children have never been found. The investigations made were so foolproof that the two sisters are due to become the first women to be hanged in India in 72 years. The sisters had exhausted all court appeals against their death sentence, and the President of India had reject their plea for mercy. His lecture became more gripping as he informed the students about the details of the investigations carried out by him in the case.

The response to the guest lecture was overwhelming and about 300 students attended the guest lecture held at the Moot Court Hall of the Law Department. The lecture was very well received by the students.
